The weather has turned cold and the holidays are upon us. It is hard to believe that a year has gone by already. I am very happy to report that we have accomplished quite a lot this year. A few of these things were on my personal “bucket list” for the Alumni, and it makes me very proud to be able to say that we can check them off.

We received notification from the IRS that **our 501 c 3 status has been approved** and is retroactive to the date we filed for the status in June. (See article on Page 3.) This is a HUGE step for the Tahosa Alumni Association. I have to give a great “Thank you” to Keith Kennedy for doing all the research, filling out all the paperwork, and his tenacious effort for us in getting this accomplished. Fund raising will be much easier in the future because of this.

For all of you who have worked on, done fund raising for, dreamed of, wished and prayed for a Tahosa Alumni Museum, you can now rest a little easier. Recently, on behalf of the Tahosa Alumni Association, I signed an agreement with the Denver Area Council for a secure large room within the Council Office for a museum. I also signed an agreement with a VERY generous benefactor, who is donating his entire museum to the Tahosa Alumni Association. While I cannot go into all the details in this printing, suffice it to say that in January 2014 we should be able to move into the room at the Council office and start the process of setting up what should be a long and prolific union between TAA and DAC for the education of Scouts and Scouters. TAA Receives Tax Exempt Status —

Effective June 24, 2013, Tahosa Alumni Association received exempt status under Section 501 (c) (3) of the Internal Revenue Code. In short, this means that your dues and donations to the Association are now deductible on your tax return as charitable contributions. As required by IRS regulations, we will provide a receipt for any donation of \$250 or more. For smaller amounts, the IRS accepts "a bank record (such as a cancelled check)" as adequate documentation. Some people may feel more confident having a receipt in hand, even for donations of less than \$250, and we will provide such receipts upon request.

We think this may be a significant event for TAA, as we have identified a few sources inclined to make significant donations now that we have the exempt status. This will enable us to do even more toward ensuring the future of Camp Tahosa.

"Hooked on Tahosa" Fly Fishing Merit Badge Program Moves to May 2014







Ranger's Roost —

For those of you who missed the November Alumni Banquet, I thought I should go over a few important milestones that happened at Camp Tahosa during 2013.

⇒ Almost 1,200 individuals attended summer camp at Tahosa on our 75th Anniversary, which is 75% of our capacity as a camp. This is a new record since summer camp re-opened in 2003. An awesome staff created a lot of good memories for a lot of Scouts and Scouters. Making memories is a long-standing tradition at Tahosa.

⇒ Two of the camp staffers this summer were interns, whose salaries were sponsored by certain Alumni members. The salary for the Assistant Ranger position was also Alumni-sponsored. The savings generated by these sponsored salaries, allowed the Denver Area Council to use these monies for program improvement and supplies for a better summer camp experience. Well done!

⇒ A new COPE course was started in March and completed in June, before the start of summer camp. The new course is built on seven Xcel-donated telephone poles and offers 15 separate elements of challenge to participants. The new course was a big hit with summer campers who were allowed to get just a "taste" of the entire course. There were four groups after summer camp who signed up for the full weekend course and all were quite impressed. As word gets out, this program will really take off.

⇒ I have started tracking numbers of campers closely and announced at the Banquet my results from October 2012 to October 2013. Tahosa hosted 5,206 individual campers, which resulted in 13,350 camping nights and 18,578 camping days. This proves that Tahosa is becoming a busy place!!

⇒ The week after the official close of summer camp, we hosted 180 Knights of Heroes. This is a group of Big Brother/Big Sister types who sponsor young men and women who have lost a parent to the war. Their goal is to afford these young people an opportunity to experience the good things in life that often can't happen in a single parent environment. This is the fourth year that KOH has used Tahosa as part of the experience. God bless them!

⇒ We had a pretty full year of camping and programs as well. Tahosa hosted Okpik Winter Program, Gateway District's Webelos Weekend, Fall Wood Badge, Order of the Arrow Cony Party #3, and campers from all districts and surrounding Councils on any available weekends.

⇒ The Alumni Association sponsored a funded work project, which took out the old waterfall at the end of the spillway and replaced it with two rock-lined ponds that allows the water to spill from one pond to the second and then continue under the chapel walkway and on to the South St. Vrain.

⇒ Flooding was a hot topic for a while in September. Tahosa was not significantly impacted physically by the flood waters, but road travel to and from Tahosa was a problem for a month or so. A new relationship was formed because of the flooding near Jamestown. A privately operated outdoor education school known as Cal-Wood had their access road washed away and needed a place to run their classes during the week. A quick transformation of the buildings at Tahosa made room for 80 Fifth Graders on weekdays

and then transformed back for Scout camping on weekends. It's a perfect fit. After December 15th, Cal-Wood was able to move back to their own facility.

The most recent news at Camp involves the 70–80 mph winds that have plagued the area during November. Nearly 100 additional trees have been blown over, mostly in the areas where thinning for fire mitigation has taken place. The thinning is an important part of maintaining the health of the forest, as well as safety from potential fire. However, the wind can, and does, cause additional loss of trees.

As I write this message, Tahosa is getting its first good supply of snow. The lake has four inches of ice and is bound to get much thicker with the impending cold snap. The entire "look" of the camp has once again transformed into a white wilderness.

The Denver Area Council welcomes all Alumni members to visit Camp Tahosa and reminisce about the good old days of summer or winter. Make certain your troops know about all Tahosa has to offer and get them up here, so they can start making memories of their own.




Due to the generosity of a member of the Tahosa Alumni Association, Bob Munger, we now have acquired a huge collection of BSA historical materials, beginning with a few items from the early days of the BSA in 1916, to fill a "Tahosa History of Scouting" room at the Denver Area Council headquarters in Lakewood.

We have a huge task before us as we need to sort, catalog, and prepare many of the items from Bob's "Arapahoe Scout Museum" collection.

Foremost on our list of needs is a storage place for the many boxes and file cabinets that we will need to store these many, many items that will eventually make their way into the museum room at the DAC in the future, both for the initial display and for ongoing rotating themes. Almost any amount of space can benefit us if it is more than 400 square feet up to 1000 square feet. We need to have a secure location over the next year at least, where we can occasionally change out processed boxes and file cabinets for ones we have not yet processed. Please let us know if you have such a space available for us to use. Even if someone has a vacant two-car garage or a couple of one-car garages in the west part of town, this would help us a great deal. Next is the actual moving of the items into storage and into the display room, followed by sorting and cataloging activities that will require some volunteers as needs arise. We have a lot of sorting and identification activities coming up in 2014, so any assistance would be greatly appreciated!!!

We are looking forward to this challenge and will keep you updated as things unfold.
